## Membership Agreement and Policies

### Cancellation & Refund Policy

#### Yearly Membership Rates

Yearly members are liable for 12-month membership beginning January 1 of the current year and ending on December 31 of the current year. If the member joins after January 1 of the current year, they understand that their membership will end on December 31 of the current year, and they will not be entitled to a pro-rated membership rate or refund if they decide to cancel their membership before the term ends on December 31 of the current year. Will County Seniors understands that life happens and will honor cancellations before the 12-month period for the following reasons only:

- Relocation of greater than 25 miles with documentation
- Medical reason with doctor's note

#### Monthly Membership Rates

All monthly memberships must be paid in full, or a debit/credit card must be kept on file for a monthly subscription. Any member that chooses the monthly payment subscription agrees to an automatic payment that will be deducted on the day of the month that the member joins, continuing each month until membership expires on December 31 of the current year. The member will be liable for updating any debit/credit card information if needed.
